PROGRAMME

- (a) 11th June, 2019 (Tuesday) as the last date for making nominations;
- (b) 12th June, 2019 (Wednesday) as the date for the scrutiny of nominations;
- (c) 13th June, 2019 (Thursday) as the last date for withdrawal of candidatures;
- (d) 21st June, 2019 (Friday) as the date on which a poll shall, if necessary be taken and;
- (e) Counting of votes will take place after the close of poll on the polling station itself.
- (f) 23rd June, 2019 (Sunday) as the date by which the election shall be completed.

Note: 5th June, 2019 (Wednesday), 7th June, 2019 (Friday) being Gazetted holidays and 8th June, 2019, Second Saturday being a public holiday, no nomination will be received on these days.

3. In pursuance of the provisions of Section 57 of the Punjab State Election Commission Act, 1994 (Punjab Act No.19 of 1994), the Election Commission hereby fixes poll hours from 8.00 AM to 4.00 PM during the poll on **21st June, 2019** to conduct the general elections/bye-elections. Further, in accordance with the instructions contained in the Presiding Officers Diary instruction 69, all electors present at the Polling Station at the hour of the close of poll shall be entitled to have their votes polled.

Model Code of Conduct has come into force from the date of announcement of elections i.e. 27.05.2019 within the revenue jurisdiction of the Municipal Corporations/Municipal Councils/Nagar Panchayats till the completion of the election process.
