## NOTIFICATION The 10th-February, 2015

No.SEC-ME-2015/ 711 :- The Government in the Department of Local Government, Punjab vide Notification No. 3/7/2013/MEO/EA/9830 dated 16.12.2014 and Notification No.3/7/2013/MEO/EA/925, dated 02.02.2015 has directed that general elections to elect the members of 123 Municipal Councils/Nagar Panchayats and bye-election to elect member of ward No. 02 (General) of Nagar Panchayat, Bariwala, District Sri Muktsar Sahib be held by 25th February, 2015.

2. Now, therefore, in pursuance of the provisions contained in Section 35 of the Punjab State Election Commission Act, 1994 (Punjab Act No.19 of 1994) the State Election Commission, Punjab hereby appoints the following dates for general election of 123 Municipal Councils/Nagar Panchayats shown in the enclosed schedule and bye-election of ward No. 02 ( General) of Nagar Panchayat, Bariwala, District Sri Muktsar Sahib . **The 10th February, 2015 between 11 AM to 3 PM as in accordance with Section 38 of the Act ibid will be the first day of filing nominations:-**

### PROGRAMME

- (a) 13th, February, 2015 (Friday)  
as the last date for making nominations;
- (b) 14th February, 2015 ( Saturday)  
as the date for the Scrutiny of nominations;
- (c) 16th February, 2015 ( Monday)  
as the last date for withdrawal of candidatures;
- (d) 25th February, 2015(Wednesday)  
as the date on which a poll shall, if necessary be taken and;
- (e) Counting of votes will take place on the same day after the close of poll at the polling station itself, and the results declared soon thereafter.
- (f) 27th February, 2015 (Friday)  
as the date by which the election shall be completed.

**Note: 14th February, 2015 is not a holiday under Section 25 of the Negotiable Instruments Act, 1881, as such the Scrutiny of nominations will take place on that day.**

In pursuance of the provisions of Section 57 of the Punjab State Election Commission Act, 1994 (Punjab Act No.19 of 1994), the Election Commission hereby fix poll hours from 8.00 AM to 4.00 PM during the poll on 25th February, 2015 to conduct the general elections of Municipal Councils/Nagar Panchayats. Further, in accordance with the instructions contained in the Presiding Officers Diary instruction 69, all electors present at the Polling Station at the hour of the close of poll shall be entitled to have their votes polled.

With the issue of this notification on 10th February, 2015 Model Code of Conduct comes into effect immediately within the jurisdiction of the respective Municipal Councils/Nagar Panchayats areas and also in the ward No. 2(General) of Nagar Panchayat, Bariwala, District Sri Muktsar Sahib where the elections are to be held till the completion of the poll.
