

No.SEC-ME-2015/ 709 .- The Government in the Department of Local Government, Punjab vide Notification No. 3/7/2013/MEO/EA/885, dated 02.02.2015 has directed that general elections to elect the members of Municipal Corporation, Pathankot, Phagwara, Hoshiarpur, Sahibzada Ajit Singh Nagar, Moga & Bathinda and bye-elections to ward No. 49 (General) of Municipal Corporation, Jalandhar and Ward No.08(BC) & ward No. 46 (General) of Municipal Corporation, Patiala be held by 22nd February, 2015 instead of 20th February, 2015.

2.. Now, therefore, in pursuance of the provisions contained in Section 35 of the Punjab State Election Commission Act, 1994 (Punjab Act No.19 of 1994) the State Election Commission, Punjab hereby appoints the following dates for general election to Municipal Corporations of Pathankot, Phagwara, Hoshiarpur, Sahibzada Ajit Singh Nagar, Moga & Bathinda and for bye election of ward No.49 (Genl) of Municipal Corporation, Jalandhar, ward No. 08 (BC) & ward No.46 (Genl) of Municipal Corporation, Patiala .The 7th February, 2015 between 11 AM to 3 PM as in accordance with Section 38 of the Act ibid will be the first day of filing nominations:-


PROGRAMME

- (a) 11th, February, 2015 (Wednesday)
as the last date for making nominations;
- (b) 12th February, 2015 (Thursday)
as the date for the Scrutiny of nominations;
- (c) 13th February, 2015 (Friday)
as the last date for withdrawal of candidatures;
- (d) 22nd February, 2015(Sunday)
as the date on which a poll shall, if necessary be taken and;
- (e) Counting of votes will take place at 10.00 A.M. on 26th February, 2015 for which separate instructions have been issued to District Electoral Officers, and Additional District Electoral Officers.
- (f) 27th February, 2015 (Friday)
as the date by which the election shall be completed.

Note: 7th February, 2015 is not a holiday under Section 25 of the Negotiable Instruments Act, 1881, as such the nominations will be received on that day.

In pursuance of the provisions of Section 57 of the Punjab State Election Commission Act, 1994 (Punjab Act No.19 of 1994), the Election Commission hereby fix poll hours from 8.00 AM to 4.00 PM during the poll on 22nd February, 2015 to conduct the general elections/bye elections. Further, in accordance with the instructions contained in the Presiding Officers Diary instruction 69, all electors present at the Polling Station at the hour of the close of poll shall be entitled to have their votes polled.

With the issue of this notification on 7th February, 2015 the Model Code of Conduct comes into effect immediately within the jurisdiction of the respective municipal Corporations areas and also in the three wards namely ward No.49 (Genl) of Municipal Corporation, Jalandhar and ward No. 08 (BC) & ward No.46 (Genl) of Municipal Corporation, Patiala where the elections are to be held till the completion of the poll.
